In exercise of the powers conferred by sub-section (1) of section 9 of the Rajasthan Stamp Act, 1998 (Act No. 14 of 1999) and in supersession of this department's Notification No. F.4(4)FD/Tax/2015-230 dated March 9, 2015, the State Government being of the opinion that it is expedient in public interest so to do, hereby orders that the stamp duty chargeable on the instrument of debt assignment executed in respect of performing assets (standard assets), shall be reduced and charged at the rate of 0.15 percent of the amount of debt subject to maximum of rupees five lacs, with effect from March 9, 2015, subject to condition that the stamp duty already paid shall not be refunded.
